14. Assessment Criteria

- 14.1 Comply with the theme (40%), overall aesthetic appeal (30%), and creativity (30%).
- 14.2 If the entries fail to meet the award requirements after being reviewed, the prize may not be awarded.
- 14.3 The final decisions made by the jury committee shall prevail, and no appeals will be entertained.

15. Evaluation Procedures

The submitted artworks will undergo two rounds of selection. Upon passing the initial round, the Macau Artist Society will notify the respective students via phone and SMS to submit their physical artwork entry either to the Macau Artist Society office (Address: Avenida do Conselheiro Ferreira de Almeida No. 49, Edifício SAN HEI KOC FL1 FLAT C, D, Macao; Office hours: Monday to Friday, 10:00a.m. to 5:00p.m.) or collectively at their schools (where Macao Art Association personnel will be designated to collect the entries). Please refrain from including personal information on the front or back of the entry. Kindly affix the entry form to the back of the entry artwork and enclose it in a sealed bag during submission.

The results of the initial round of selection and the list of the chosen artwork entries will be announced by late November on the Macao Artist Association webpage at <http://masmacau.com> and on its Facebook page.

16. Announcement of Winners

The list of award recipients, the award ceremony date and location will be revealed in the first quarter of 2025 on the webpages of the Macao Government Tourism Office at <https://fireworks.macaotourism.gov.mo/index.php> and the Macau Artist Society at <http://masmacau.com> as well as on its Facebook page. Winners will be notified individually.
